Dear Ms. Bohac:

This letter is intended to supplement the comments and request for a contested case hearing filed by the Central Texas Water Coalition, Inc. (CTWC) in May 2013 regarding the Lower Colorado River Authority's (LCRA's) Application to amend its Water Management Plan (WMP). This filing is timely made in response to the Texas Commission on Environmental Quality's (TCEQ's) July 8, 2015 Notice of the LCRA's Application to amend its WMP and the draft TCEQ Order approving the amendments to the WMP.

As detailed in CTWC's May 27, 2013 comments and request for a contested case hearing on the LCRA WMP Amendment Application, the LCRA's management of the water in Lakes Travis and Buchanan is critically important to the CTWC and its members. The LCRA Application now pending before the TCEQ has addressed and resolved a number of important and critical issues, as generally outlined in the most recent TCEQ Notice. In recent months, CTWC and others have provided additional comments and suggested clarifications, and CTWC is hopeful that its comments will be satisfactorily addressed by the Applicant and the TCEQ, so that the newest LCRA WMP may be immediately approved without the need for a contested case hearing.
